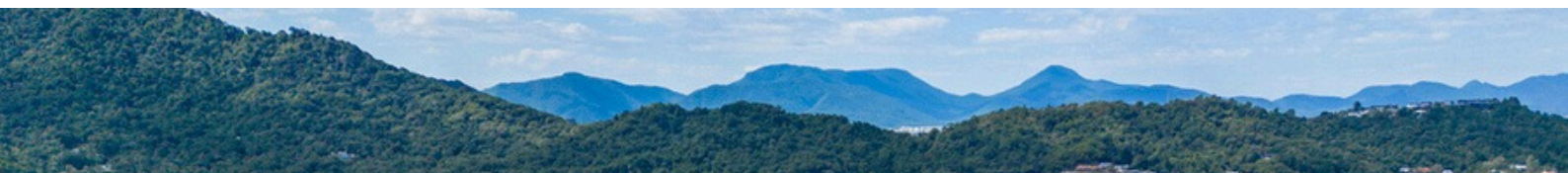

The annual tuition fee covers all compulsory curriculum activities including excursions and camps. This ensures there are no surprise costs, enabling families to plan their finances effectively without unexpected expenses.

Sibling discounts apply when a family has two or more children attending the College at the same time. The 1st child rate applies to the child in the highest year level.

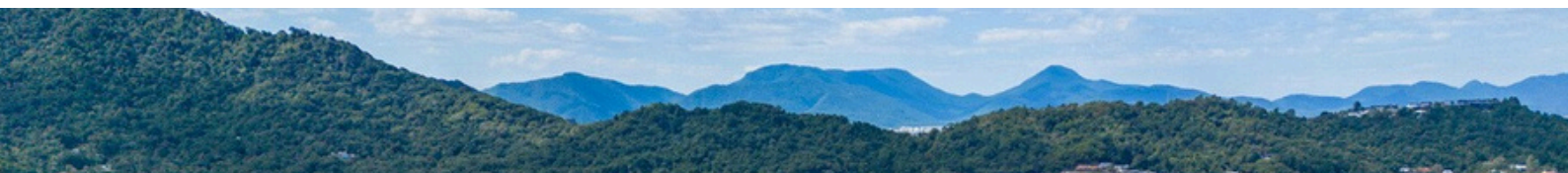
For students in Years 5-12, the annual tuition fee also includes Chromebook rental under the College Managed Device Program (MDP).

Stationery is included in the tuition fees for Primary students (P-6).

Families have the flexibility of paying annual fees up-front or on a payment plan spread over instalments throughout the year.

A 5% Discount applies when annual tuition fees are paid upfront by the due date stated on the annual invoice. This does not apply to students starting part way through the year.

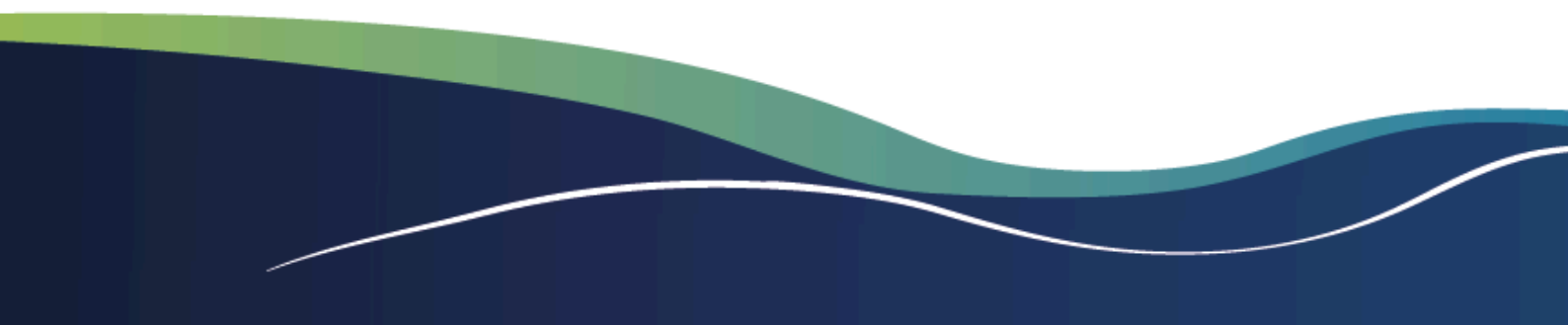
If using internet banking, please ensure that you use your numerical account code shown on your invoice as the payment reference to ensure payment allocation is to the correct account.
